Logistics Cost in Lao PDR

"Reducing the costs (time and money) and simplifying the procedures for transporting freights to and from neighboring countries" was one of the most focused policy recommendations at the policy-oriented seminar with a title of "Enhancing Industry in Lao PDR: Service Liberalization, Simplification of Investment Procedures, and Human Resource," held by Institute of Developing Economies, Japan External Trade Organization (IDE-JETRO), Japan External Trade Organization (JETRO) and Ministry of Planning and Investment, Lao PDR (MPI) in 2015.




Figure 1: Cost of shipping a 40-foot container to Yokohama Port, Japan

Figure 1 shows the cost of shipping a 40-foot container to Yokohama Port, Japan from major production bases in Asia. As shown in the figure, the shipping costs of 40 feet container from Vientiane are outstanding.

The cost of the survey conducted in 2014 was broken down into land transportation

cost from Vientiane to Bangkok (Klong Toey) Port (US\$ 1,700) and shipping cost from Bangkok Port to Yokohama (US\$ 800). It was also reported that the land transport cost between Laem Chabang Port and Nong Khai, the border city in Thailand on the way to Vientiane was US\$ 700 for the reference. Considering that the difference of the cost to Bangkok Port and to Laem Chabang Port is not so large, the logistics cost between Vientiane and Nong Khai is around US\$ 1,000.

Then several questions arise. Is the cost of a way of 20km between Vientiane and Nong Khai so high? What are the reasons? Is it because of the logistics cost in Lao side between Tha Na Laeng? Or is it because of cross-border cost between Lao PDR and Thailand? Or is it because of a problem of "load on one side"? As a matter of fact, trucks from Laem Chabang Port or Bangkok Port to Vientiane are forced to transport with empty to transport goods from Vientiane to those ports.

In order to answer these simple questions, we conducted a survey in the fiscal year of 2016. In the survey, we interviewed with several logistics firms with nationalities of Lao PDR, Thailand and Japan. We made actual travels from Savannakhet to Laem Chabang Port and from Vientiane to Klong Toey port and measured the distances and time. In this seminar, we would like to show the survey results and discuss with researchers, government officials of Lao PDR, representatives of international organizations and foreign development agencies.
